Record Book of the Grand Valley Water Users Association

Grand Junction, Colo.
October 18, 1904

At a meeting of the citizens of Grand Junction and Mesa County, Colorado, called for the purpose of organizing a Water Users Association to cooperate with the Government officials in matters relative to the construction of the high line canal in Mesa Co. Colorado, Mr. L. M. Miller was upon motion of P.A. Rice, seconded by Fred W. Barbour, elected Chairman.

W.L. Mulkey was upon motion elected Secretary.

Chairman L. M. Miller called the meeting to order, and the object and purpose of the meeting were discussed by L. M. Miller, W. S. Wallace, George Smith, Geo. A. Jackson, H. H. Beach, James H. Smith, and others. A motion prevailed that the meeting proceed to organize a Grand Valley Water Users Assn.

A motion prevailed that the Chairman appoint a committee of three to select and suggest to the meeting the names of eleven citizens available for President, Vice-President, and nine directors of the proposed Grand Valley Water Users Assn. The Chairman appointed the committee as follows: W. S. Wallace, Chairman, Albert Robinson, Fred W. Barber.

Recess of fifteen minutes taken.

Upon meeting being called to order, W. S. Wallace, Chairman reported that the committee recommended the following citizens for officers and directors of the

A motion prevailed that an assessment of one cent per acre be made upon all land to be covered by the proposed high line canal to defray any expenses incurred by the officers and directors of the Grand Valley Water Users Assn.

Grand Junction, Colorado, Oct. 24, 1904

Meeting of the Directors as named at the Land Owners meeting on the ___???. The meeting was held at the office of Lawrence M Miller in Grand Junction, Colorado in accordance with the call therefor.

The meeting was called to order by Lawrence M. Miller, President. Members present Lawrence M. Miller, Marion O Delaplain, James B. Hunter, Merrill W. Blakslee, James H. Smith, George Smith, Henry H. Beach, and William S. Wallace. Absent S. P. Green, Daniel Lynch and John T. Beaman.

The first business before the meeting being the election of a Secretary (**it**) was moved by James H. Smith, seconded by Marion O. Delaplain, that the salary of the Secretary be placed at one hundred dollars per month. Carried.

Moved and seconded that W. S. Wallace be elected Secretary. Carried.

The matter of the employment of Counsel for the Board being under discussion. It was moved and seconded that Chas. A. Caswell be employed as temporary Counsel.

Moved and seconded that we adopt this form of Articles of Incorporation, as adopted by the Uncompahgre Valley Water Users Association. Carried.

Moved and seconded that we adopt this name, "The Grand Valley Water Users Association." Carried.

Moved and seconded that the capital stock of this association be placed at \$75,000, divided into seventy-five thousand shares of the par value of one dollar for each share. Carried.

Moved and seconded that a committee of three be appointed by the Chair to act with the attorney in preparing the Articles of Incorporation to be submitted to the next meeting of the Board. Carried.

The Chair appointed M. O. Delaplain, Geo. Smith, and W. S. Wallace as such committee. Carried.

Moved and seconded that M. O. Delaplain be elected Treasurer of this association. Carried.

Moved and seconded that the compensation of Directors of the Association be fixed at two dollars per day for each meeting attended and five cents per mile for each mile traveled one way. Carried.

Moved and seconded that we levy an assessment of five cents per acre upon all the land to be covered by the contemplated canal. Carried.

Moved and seconded that the Seal of this Association be a figure of two concentric circles, the outer being two inches and the inner being one and one half inches in diameter. In the space between the two shall be the words "The Grand Valley Water Users Association" and bearing within the center space an unrolled scroll with the words and figures thereon "Incorporated 1904" seal," Colorado."

Moved and seconded that the President, Secretary, and George Smith be elected as Executive Committee to act when the Board is not in session and perform such services as are usually performed (*by*) such committee. Carried.

Moved and seconded that we do now adjourn subject to call by the Secretary. Carried.

Meeting of the Board of Directors of the Grand Valley Water Users Association held at the office of the Secretary in Grand Junction, Colorado in accordance with the call by the President.

Members present: L. M. Miller, H. H. Beach, John T. Beaman, Jas. B. Hunter, George Smith, M. O. Delaplain, W. S. Wallace, Jas. H. Smith.

The meeting was called to order by the President.

The Secretary reported that he had received a total subscription of 22,127 acres and that it will take 2,244 acres additional to complete the 90% required by the Government before work can begin.

The committee on Bylaws made its report, submitting a set of Bylaws for the Association. It was moved and seconded that the report of the committee be accepted and that the Bylaws as reported be adopted as the Bylaws of this association. Carried.

The Secretary was instructed to have the Bylaws properly copied in a book to be kept for

It was moved by Mr. J. H. Smith, seconded by Mr. Delaplain that the Secretary be authorized to draw a warrant in his favor for \$129.00, the cause being for maps, \$4.00, stereography for Henry's meeting \$5.00, expenses of John Stynes to Red Cliff \$20 and one month's salary for Secretary - \$100.00. Motion carried.

It was the sense of the meeting that we defer the final report for a few weeks and make an especial effort to secure the full acreage of 90%.

There being no further business before the meeting on motion the Board adjourned to meet at the call of the President.

Meeting called to order by the President. The minutes of the meeting of October 28, 1905 were read and approved.

Mr. Aupperle and Senator DeLong reported that they had conferred with Secretary Garfield on the occasion of his recent visit to Colorado and had made certain statements in reference to the Grand Valley Project, and they asked the Board of Directors of this company to officially approve such statements, and to prepare a statement in accordance with the facts along the same lines and have the same signed by the officers of this Association and forward to Secretary Garfield.

It was moved by Mr. Beach, seconded by Jas. H. Smith, that a committee of three including the Secretary be appointed by the Chair to draft such a statement and present the same to the President for official signature and approvals. Carried.

The Chair appointed Mr. Beach, Mr. Aupperle, and Senator DeLong to act with the Secretary in such capacity.

Moved and seconded that we adjourn. Motion carried.

Meeting of the Board of Directors of the Grand Valley Water Users Association held at the office of the Association, pursuant to call by the President. Members present: L. M. Miller, S. P. Green, H. H. Beach, Daniel Lynch, Jas. B. Hunter, George Smith, M. O. Delaplain, W. S. Wallace, Jas. H. Smith, and M. W. Blakslee. Minutes of the last meeting were read and approved.

The report of the committee appointed at the last (*meeting*) to draft a communication to Secretary Garfield was presented and on motion was approved and adopted.

Mr. Aupperle, as Secretary of the Chamber of Commerce and special representative of the Association who had just returned from Washington D. C. was present and submitted his report, stating the position of Secretary Garfield and Director Newell, and submitted the proposition as delivered to him to the Association. It was then moved and seconded that the following resolution be adopted to wit: Resolved by the Board of Directors of the Grand Valley Water Users' Association, that we accept the second proposition of Mr. Secretary Garfield as given in his letter to Mr. Aupperle of November 5th, and that we request the Secretary to order the survey and location of the line of canal of the Grand Jct. project at the earliest practicable moment. Carried.

Mr. Jas. H. Smith then moved the adaptation of the resolutions, seconded by Mr. Hunter. Be it Resolved, by the Board of Directors of the Grand

Valley Water Users Association, that the engineers of the Reclamation Service be requested to investigate the irrigation of Orchard Mesa in conjunction with the other matters in the Grand Valley Project, believing that the Department is misinformed as to the wishes of the citizens and owners of land in that locality, as favoring construction by private capital and as to the ability of private parties to construct adequate canals in that locality. The Orchard Mesa section is represented by three directors in this body and the deeded lands in that section have subscribed to the contract of this Assn. Carried.

Moved and seconded that a mass meeting be called of all the members of this Association and of all land holders and claimants in Grand Valley, whose lands will be irrigated by the Government project, for Thursday the 14th Day of October, 1907 at 8 o'clock P.M. at the Auditorium for the purpose of submitting the foregoing resolutions for their approval or rejection, and that action of such meeting be reported by the Secretary to Mr. Garfield. The motion was carried.

Moved by Jas. H. Smith, seconded by Dr. Green, that the Secretary be authorized to purchase blank books in which to record the contracts of this Association and to have the same recorded at the same time the work is done by the County. Motion carried.

Moved and seconded that we adjourn subject to the call of the President.

Meeting of the Board of Directors of the Grand Valley Water Users Association held at the office of the association, pursuant to adjournment. Meeting called to order by the President.

Members present – Miller, Beach, Hunter, Geo. Smith, Jas. H. Smith, M. W. Blakeslee, M. O. Delaplain and W. S. Wallace.

The purpose of the meeting being to hear the report of the committee who went to Denver to confer with the officials of the Reclamation Service and the representatives of the Orchard Mesa District. The report was called for and it was announced by Messrs. Wallace and Geo. Smith that it had been agreed that Mr. Sands should make the report. Mr. Sands then presented his report in writing, stating the action taken and that all facts and statements had been forwarded to Washington for decision.

Mr. Geo. Smith suggested that the Orchard Mesa District would be willing to release any person owning lands on Orchard Mesa who desired to withdraw from the district and later water from the Government Canal, and in exchange asked that any person who had subscribed for Government water and who wished to later water from this district be allowed to withdraw from the Government filing.

An informal discussion followed and it was moved and seconded that a committee of three be appointed, one of whom should be the President, to confer with a like committee from the Orchard Mesa District to see if we cannot arrange a basis on which we can work in harmony.

The Chair appointed Delaplain and Wallace as the other members of the committee.

On motion, the Board adjourned subject to the call by the President.

The motion was seconded by Mr. Delaplain. Motion carried.

There being no further business, on motion the board adjourned subject to the call by the President.

S. Wallace, M. O. Delaplain, J. H. Smith, M. W. Blakslee, and D. W. Aupperle to act as such...
