

THE ORDINARY FELLOW WINERY HISTORY TALK Thursday, Feb. 22 at 6 p.m. Curtis Martin - "Bright Beads and Rusted Relics: Innovative Archaeology on a 19th Century Ute Indian Site"

The February history talk at The Ordinary Fellow Winery on Thursday, the 22nd will be presented by Curtis Martin, principal investigator for the Wickiup Project and author of *Ephemeral Bounty:* Wickiups, Trade Goods and the Final Years of the Autonomous Ute published in 2016.

His work has been studying protohistoric and early historic Ute occupation of western Colorado. For the February 22 program, he will talk about interesting findings at the McMillen Archaeological site near Delta.

3,753 ISSUES OF THE PALISADE TRIBUNE NOW DIGITIZED

Thanks to generous donors, we have digitized another 204 issues of The *Palisade Tribune* which are available on the Colorado Historic Newspaper Collection (CHNC) and Plains to Peaks Historic Newspaper databases. 120 YEAR AGO COLUMN

For decades, one of the most popular columns in *The Palisade Tribune* was the "It Happened Here" page where the editors would summarize news of interest from issues in the past. We have raised funds to digitize 3,753 issues in the Colorado Historical Newspaper Collection.

Palisade was incorporated in 1904

In as much as Palisade was formally incorporated as Palisade in April 1904 – making the Town officially 120 years old this year – we found some interesting articles about the Town's founding.

In the February 13, 1904 issue was a report from the committee appointed for the purpose of incorporating the town of Palisade:

By conferring with the best legal authority in the county we find that the limit of taxation that can be made by a corporation upon any property is three per cent, and that the average corporation tax throughout this state is five mills or one-half per cent.

As near as your committee can learn the assessed valuation of the property in the proposed limits of the town of Palisade will be \$75,000 when the new tax schedule is made next May. The boundaries of the proposed corporate limits

will be increased by taking in the north half of the Lyons ranch, now owned by Mr. Landreth, the north half of E. E. Hampton's orchard. Landreth's addition, a row of lots along the east side of W.E. Bell's and J. L. Oliver's orchards, a row of lots on the north side of First street extending as far east as C. S. Reed's ranch, also the tract of land south of the railroad owned by C. S. Reed and the one acre tract on which the canning factory is to be erected. As it is absolutely necessary that plat for filing is correct in every respect the proposed lines will be surveved bv competent engineer. a The following is a paragraph from the Colorado statutes relating to incorporation which may be of interest to the public:

4364 When the inhabitants of any part of any county not embraced within the limits of any city or incorporated town, shall desire to be organized into a city or incorporated town they may apply by petition in writing, signed by not less than thirty of the qualified electors who are land owners of the territory to be embraced in the proposed city or incorporated town to the county court of proper county: which petition shall describe the territory proposed to be embraced in such city or incorporated town, and shall have annexed thereto, an accurate map or plat thereof, and state the name proposed for such city or incorporated town, and shall be accompanied with satisfactory proofs of the number of inhabitants within the territory embraced in said limits; provided however, that in no case shall there be incorporated in such city or incorporated town any undivided track or tracts of land consisting of forty or more acres lying within the proposed limit of such town without the consent of the owner or owners thereof unless such land be surrounded on at least three sides by platted land. The petition requiring the signatures of the property owners will be circulated as soon as same can be properly drawn up.
